

FAST 5 SOCCER FACILITY RENTAL RULES AND REGULATIONS

All party renters and their guest must comply with all of the following policies and procedures of Fast 5 Soccer.

The policies, procedures and agreement may be amended at Fast 5 Soccer's sole discretion.

1. Any rental of the space for a private party must pay a deposit of \$50.00 to securely hold the desired date. Date is not reserved until deposit has been received. Payment in full is due at the completion of party and deposit will be applied towards the balance.
2. Standard Rentals are for 2 Hours, time can be added at an additional cost. Renter will be allowed in the facility 30 minutes prior to scheduled start time and is expected to have party over and items cleared away 15 minutes after scheduled end time. If you need additional time to set up prior to the party, arrangements can be made with the staff. If the party goes over the scheduled rental time the renter will be charged an additional time of \$50.00 per each 30 minutes over beginning 15 minutes after scheduled end time.
3. Rental includes full access of one field, allocated patio space, access to interior building space and one allocated staff personal for field supervision and play. Renter and all invited guest are to play only on their designated field of play at all times. Field usage is not limited to soccer play. Additional fields may be rented at the cost of \$50.00 per field.
4. Absolutely NO outside alcohol beverages may be brought to the facility or parking lot area. Outside food may be brought in for the sole purpose of the party and guests. NO coolers may be brought on premises other than for the purpose of water and food for guests. Food and drinks are NOT to be taken on the fields and must be kept in patio and building area. We do have limited refrigeration available to store Cakes and other items if needed. Beer and wine bar will be open during your party if requested. We do offer water and Gatorade packages for the party.
5. Damage and cleaning - Renters are not required to clean up after your party, HOWEVER, any excessive damage or excessive mess left by children or adults resulting in extra cleaning of the facility will result in an extra charge of \$25.00. Any damage done to the facility or property shall be billed to the renter for either repair or replacement.
6. Personal Property. Fast 5 Soccer is not responsible for personal belongings. It is the sole responsibility of each person entering the facility to be responsible for all belongings. Under no circumstances will Fast 5 Soccer take responsibility for any lost, missing or stolen property personal or otherwise.
7. Parents of children of the invited guests are completely responsible for the well being and behavior of their minor while on the premises of Fast 5 Soccer. Parents are responsible for redirecting inappropriate play and/or behavior.
